

Initial Pathway Plan Introduction

The Initial Pathway Plan for a young person should incorporate a Needs Assessment. The Leaving Care Act requires that this assessment be completed for the young person's 16th birthday, but it is recognised that care and sensitivity will be needed for many given proximity of GCSE exams.

All young people should have their needs fully assessed before they leave care. The assessment forms the basis of a clear and detailed Pathway Plan leading to independence. For many young people in care their Family Assessment will have been conducted some time earlier and will have been for a different focus and purpose. For this reason the Initial Pathway Plan should be seen as a stock-take on the original assessment and consequent care plan. The initial Pathway plan will change the focus from care to independence.

It is very important that this Needs Assessment is completed as thoroughly as possible in order to provide an accurate picture of the services and support that the young person is going to need over the crucial next two years and beyond. It will also help identify who is best placed to provide that support, and when.

The young person should be involved with the Initial Pathway Plan but they may need support in understanding that the Needs Assessment aspects are a summary of the professionals' views of their situation and needs. The views of the young person must be recorded if they disagree with the any part of the Initial Pathway Plan.

In order to help social workers and personal advisors complete the Initial Pathway Plan a series of prompt questions have been developed. The prompts draw from Department for Education guidance which sets out the areas they expect a pathway plan to cover, and the Ofsted inspectors' handbook which sets out what a "Good" service for care leavers should address. There are also a series of questions which Research in Practice has developed.
